#### 91<sup>st</sup> St. Water Shed Area

 Our "cattail corner" (on the NE corner of complex), Rain fall this summer and fall kept the ground work from being done due to essentially soggy ground.

General Excavating is monitoring the soil and will determine when best to start grading out, forming and pouring a concrete flow liner. Due to a fair amount of snow late Dec. and early Jan., we will have to wait to see what the company decides. Again, for those of you who may wonder why the need to do this project. Many homeowners have issue with drainage i.e. pooling of rain water and difficulty of soil drying due to lay of the land/property on that lower end. Also, trash and other waste has become a target for this overgrown area of weeds and cattails.

# Snow Removal - Xstream Snow removal co.

Since this company is new to us this snow season, we have had to address some issues with them, thanks to feedback from owners as well as board observation and input. Concerns include <u>not</u> plowing driveways and leaving snow piled near driveways. These concerns have been addressed with the new company. (In regard to driveways, please note the crew will not plow a driveway if a car is on it, due to chance of damage to car and or snow equipment.) Also, if excessive décor i.e. planters, landscape ornaments, statuette's etc., the crew may not do a complete job on sidewalks due to risk of property damage as well.

#### Parking -

Most recently, over the holidays, on far south end of 90<sup>th</sup> St. Visitor parking lot monopolized by industrial trucks and pick- up trucks. Trucks were tagged and requested to abide by covenants. Again to those new here, whether renters or owners, these off set lots are meant to be for visitors, delivery trucks and postal carriers. Of course, for owners & renters it would be acceptable to park there for quick convenience but for a short duration. However, again to use these lots for permanent parking spots for personal and work vehicles, is not fair to your neighbors and their visitors.

Our Covenants state each owner/ unit has 4 parking spaces, 2 stalls on driveway and 2 within the garage. The common area parking areas serve as overflow parking for the Allegrini Terrace community.
